ENTRIES: Mail to: 5378 Tassajara Road., Pleasanton, CA 94588. Make checks payable to: Yarra Yarra Dressage Series. **NO FAX ENTRIES.** Management reserves the right to cancel or amend any or all classes and to add or change judges, if necessary. All entries **MUST** include photocopy of RIDER's, OWNER's, TRAINER's, COACH's US Eq. and/or USDF, and CDS cards and horse recordings. Amateurs must show amateur card w/ entry. Ponies must have pony card
FEES: Intro through 1st levels \$45; 2nd through 4th levels \$50; FEI \$55; Freestyle \$55. Office fee \$15. RV parking: \$25 per night. **Incorrect or incomplete entries may be charged \$10.00 per correction and/or may not be accepted. Add \$10.00 for USDF/GAIG Qualifying Rides.**
OTHER: US Equestrian Membership Statement is posted in the show office. All classes will be offered on both days for the 2-day show. Specify desired day on entry. No refunds after closing date w/o vet certificate **and only** if ride can be filled from wait list with same class. Changes to entries after closing date will be assessed \$10.00 per change. There will be a \$20 service fee deducted from refunds. Return check charge is \$25. Post entries will be accepted only as space allows **plus late fee of \$15 per class.** Entries are on a first-come, first-served basis. Show will close early if over subscribed. Management reserves the right to accept conditionally or cancel any entries, disqualify riders as exhibitors, prohibit exhibition of entries and cancel or combine award classes. Shows will be held rain or shine. No refunds due to weather conditions. No Quadrilles. Food is available on the grounds.

TIMES: Times will be by phone or faxed or posted on website. It is the responsibility of the rider to contact show management if times are not received.

AWARDS: Ribbons through 5th place. Prizes to 1st place in classes with 3 or more horses.

STABLING: LIMITED; stabling is permanent 12 x 12 stalls with doors. Cost is \$30 per day per stall; stalls are pre-bedded. No additional bedding or feed is available for sale on the grounds. **All stabling must be arranged in advance.**

ACCOMMODATIONS: Hotels are located nearby in Dublin/Pleasanton. Ramada Inn, Hilton, Sheraton, Marriott, AmeriSuites, Motel 6 and Holiday Inn are located in the general vicinity.

DIRECTIONS: Take the Santa Rita Rd./Tassajara Rd exit off I-580. Proceed north on Tassajara Rd. Go approximately 1 ½ miles. Ranch is on the left hand (west) side.

VETERINARIAN & FARRIER: On Call. Phone numbers will be posted at show office.

FOOTING: Show arena(s) are indoors and outdoors (as necessary), and are standard arena(s) (20m x 60m), overall dimensions approximately 100' x 240' and have sand/rubber footing mix. Warm-Up arena(s) are outdoors with similar footing.
